**\* *Requirements for Material of Conference***

We intend to publish articles till the beginning of the conference as separate book. **The articles must be prepared in Times New Roman 12, doc format, size – up to 10 printed pages, summary – up to 1 page, references used have to be shown in footnotes on every page, also detailed information about author (name, surname, scientific and/or pedagogical title, place of work, position, phone, e-mail) should be indicated in the first page. Important - all visual data used in materials will be printed in black and white.**
